2. DIRECT ARTIST SUPPORT: FANS CAN DIRECTLY SUPPORT ARTISTS BY PURCHASING EMTS, PROVIDING THEM WITH IMMEDIATE FINANCIAL BENEFITS AND THE FREEDOM TO CREATE WITHOUT CONSTRAINTS.
3. ENHANCED TRANSPARENCY: WITH BLOCKCHAIN, TRANSACTIONS AND OWNERSHIP DETAILS ARE TRANSPARENT AND IMMUTABLE, ENSURING THAT RIGHTS AND REVENUES ARE DISTRIBUTED FAIRLY AMONG STAKEHOLDERS.
4. GLOBAL ACCESSIBILITY: ARTISTS CAN REACH A GLOBAL AUDIENCE, ENABLING THEIR WORK TO BE ACCESSED AND OWNED BY ANYONE AROUND THE WORLD, REGARDLESS OF GEOGRAPHIC OR ECONOMIC BARRIERS.

A PERCENTAGE OF THE TOTAL TOKEN SUPPLY WILL BE ALLOCATED FOR ARTISTS, EARLY INVESTORS, AND THE DEVELOPMENT TEAM, WITH THE MAJORITY RELEASED TO THE PUBLIC THROUGH A SERIES OF PHASED SALES.

UTILITY AND GOVERNANCE

EMTS WILL NOT ONLY REPRESENT OWNERSHIP BUT ALSO GRANT GOVERNANCE RIGHTS, ALLOWING TOKEN HOLDERS TO VOTE ON PROJECT DEVELOPMENTS, FUTURE COLLABORATIONS, AND USE OF FUNDS. THIS INCLUSIVE MODEL ENSURES THAT THE COMMUNITY OF CREATORS AND FANS CAN STEER THE PROJECT'S DIRECTION.
